
The formula to be used for milk price adjustments from month to month will be \$ .00025 for every \$ .05 increment of increase or decrease per cwt. in the cost of raw milk as announced by CMPC Class I. Any adjustments in the price of butterfat can be adjusted on all of the lowfat products used.
